

Invitation for Bids

1. The null has allocated funds towards the cost of Construction of Blacktopped Road & RCC drain from Karaiya, Tetariya, Sedhwa, Shihorwa to Madhuwan and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Blacktopped Road & RCC drain from Karaiya, Tetariya, Sedhwa, Shihorwa to Madhuwan (Contract No: KRM/NCB/W/01/2081/082). Bidding is open to all eligible bidders as per Section V of Bidding Document.
2. Karaiyamai Rural Municipality invites electronic bids from eligible bidders for the construction of Blacktopped Road with Drainage under National Competitive Bidding – Single Stage Two Envelope Bidding procedures. Only eligible bidders with the following key qualifications should participate in this bidding:
Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 39000000
Minimum Work experience of similar size and nature: 10386000
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Karaiyamai Rural Municipality, Bara, Madhesh Pradesh, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
5. If hard-copy is allowed then a complete set of Bidding Documents may be purchased from the office Karaiyamai Rural Municipality, Bara, Madhesh Pradesh, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 5000.0 NRs. till 31-10-2024 12:00 during office hours.

Or

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

5. Pre-bid meeting shall be held at Karaiyamai Rural Municipality, Karaiya Bara at 21-10-2024 14:00 hours
7. Sealed or electronic bids must be submitted to the office Karaiyamai Rural Municipality, Bara, Madhesh Pradesh, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 31-10-2024 12:00. Bids received after this deadline will be rejected.
3. The bids will be opened in the presence of Bidders' representatives who choose to attend at 31-10-2024 13:00 hours at the office of Karaiyamai Rural Municipality, Karaiya Bara. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 800000 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
